Application Security Specialist

The purpose of the job is to ensure that necessary security standards are maintained to preserve confidentiality, integrity and availability as per international standards and best practices while assuring preventive and recovery strategies are in place and minimise the risk of internal and external security threats on corporate application suite.

Key responsibilities will include:

- Use in-depth consulting skills, business knowledge, and expertise to effectively integrate Application Security features into client business environment in order to achieve end user expectations by developing and implementing reliable, measurable, consistent and responsive security settings on application development process to ensure business continuity as per the Information Security Management framework in SriLankan IT Systems.
- Continuously monitor and review existing and upcoming web applications, web services, and internet facing applications for website vulnerabilities including, but not limited to Cross Site Scripting, Injection Flaws, Malicious Files Execution, Insecure Direct Object Reference etc. and provide expertise and guidance in consent with Requirement Study Team, Application Development Team and Application Deployment Team to influence an effective, secure environment.
- Proactively detect and mitigate internal and external security threats to applications by continuously monitoring the behaviour patterns through system events/logs and build and maintain effective firewall configurations while developing user friendly reports and alerts to ensure the effectiveness of the controls.
- Coordinate the handling and resolution of incidents of security breach to ensure the security of the cooperate information and perform or assist with investigations related to cooperate web sites 24*7 by correlating and analysing system logs and generating/creating reports for the relevant parties.
- Maintain own knowledge of data protection issues, information management and related legislation. Provide advice on related data protection laws and other issues. Maintain a register documenting personal information processing activities, define and maintain information flow maps. Review compliance with legislation (must include third-party data processors). Provide reports to the Management, Audit Committee and Board on compliance, training and awareness, in relation to data protection, compliance, IT governance and risk management.
