Or

2. Registered Medical Practitioner (R.M.P.) or equivalent qualification One (01) year's post eligibility experience in a reputed institution as a doctor

And

Should be registered with the Sri Lanka Medical Council to practise as a medical professional

Salary Code and Monthly Salary Scale relevant to MM-1-1 Service Category

Salary Code No. MM-1-1, Rs. 53,175/- 1375x10 – 1910x15 – 95,575/- as per Management Services Circular No. 02/2016.

Age limit – Should be not less than 22 years and not more than 45 years. Maximum age limit will not be applicable to internal applicants.

02. NURSING OFFICER

(Management Assistant Technical Service Category MA-2-1)

Educational and Professional Qualifications

(a) Should have passed in six (06) subjects in one sitting including English Language with four Credit passes including

I. Sinhala / Tamil

II. Mathematics

At the General Certificate of Education (Ordinary level) Examination

(b) Should have obtained the qualifying level to follow a tertiary education course passing in all subjects (except in General Common Test) at the General Certificate of Education (Advanced Level) Examination (in the Science subject stream)

And

Competency / Proficiency

Should have obtained a certificate relevant to nursing training from an institution recognized by the government and should be registered with the Sri Lanka Medical Council as a Nurse and should have one (01) year's experience in a hospital recognized by the government after the training.

Internal Applicants

1. Should have fulfilled the qualification for the external applicants mentioned above.

Salary Code and Monthly Salary Scale relevant to MA-2-1 Service Category

Salary Code No. MA-2-1, Rs. 30,310 – 300x10 – 350x7 – 495x4 – 660x20 – 50,940/- as per Management Services Circular No. 02/2016.

Age limit – Should be not less than 18 years and not more than 45 years. Maximum age limit will not be applicable to internal applicants.
