**1. Post: Deputy General Manager (01 post)**

**Qualifications:**

External Recruitment:

A Bachelor's Degree recognized by the University Grants Commission on Management/ Science/ Agriculture/ Public Administration/ Business Administration  
and

A post graduate degree qualification in the relevant field or Associate Membership of a recognized professional chartered Institute, which is relevant to the subject area of the post  
and

Minimum of 15 years` of experience at a post in "Managerial Level" in a Corporation, Board or a reputed Mercantile Establishment.

Completion of minimum five (05) years satisfactory service in Grade I in a post of Manager (MM-1-1) category in the subject area relevant to the post.

Internal Recruitment

Shall have completed at least a 05 years of satisfactory period of service in a Grade I post belonging to Junior Management Category in the field relevant to the post.

**Age:**

Candidates should be not less than 22 years and not more than 45 years of age. The upper age limit does not apply to internal candidates.
