3. Salary	Commencing from Rs. 153,000 per month as per applicable CEB salary scales

Other Benefits	<p>a) Those who are selected will be entitled to Employees' Provident Fund (EPF) with Employee's contribution of 10% and CEB contribution of 15%.</p> <p>b) Employees' Trust Fund (ETF) contribution of 3% by the CEB.</p> <p>c) Bachelor based accommodation will be provided.</p> <p>d) Those who fulfill the requirements will be placed in the applicable salary scales and they will be paid applicable allowances with effect from the beginning of the 2nd year of contract employment.</p>
