#### WHY?

Possessing an ICAO (International Civil Aviation Organization) recognized qualification is an advantage for you to be employed at any international airport. After completion of training you will be eligible to be absorbed to the AASL permanent cadre subject to availability of vacancies.

#### How?

The applicants are required to undergo a standard medical test and physical fitness test. The selectees will receive training in 3 stages.

#### WHAT?

We are looking for energetic male & female, who possess required qualifications to undergo training in Aviation Security (AVSEC) at Bandaranaike International Airport (BIA) at Katunayake and Sri Lanka Airport & Aviation Academy (SLAAA) at Ratmalana, with the aim of paving a path to them to become professionals in AVSEC.

#### STAGE 01

##### AVSEC Trainee

ICAO Standard Training Program STP 123 & Practical Training. (12 weeks)

**Step 01:** ICAO Standard Training Programme STP123 (06 weeks nonresidential programme at (SLAAA) Ratmalana)

**Step 02:** Practical Training (6 weeks nonresidential programme at BIA)

- Those who are selected from the final examination of **STAGE 01** are eligible to follow **STAGE 02**.
- Bond should be signed by the trainee at the start of the Training Programme.

#### STAGE 02

##### Airport & Aviation Trainee Security Assistant

AVSEC On-the-job Training at BIA (1 year)

- Trainees will be deployed at BIA to undergo AVSEC operational training with uniforms.
- Continuation Training Programs (04 classes per month) is mandatory for them.
- They will be paid a training allowance of Rs.40,000/= per month for 12 months.

Those who are successful at this practical training are eligible to follow STAGE 3.

#### STAGE 03

##### Airport & Aviation Trainee Security Assistant

Preparation for AVSEC Screener Certification (1 year)

- Continuation of AVSEC operational training for 12 months on payment of training allowance of Rs.60,000/= per month.
- Trainees will be prepared to face the AVSEC Screener Certification.
- Those who have successfully completed all 3 stages will be absorbed into the permanent cadre as Airport & Aviation Junior Security Screener subject to availability of vacancies.

## YOUR SUITABILITY

- Should have passed the GCE (O/L) examination with Credit passes for English Language and Mathematics.
- Preference will be given to those who have passed the GCE (A/L) examination in 03 subjects.
- Fluency in Spoken English.
- Age between 18-30 years.
- Minimum height 66" for male & 64" for female.
