A Bachelor's Degree in Chemistry / Earth Resource Mining Engineering / Gemology / Geology / Mineralogy / Business Administration or Management / Marketing Management

AND

A Master Degree in Chemistry / Earth Resources Mining Engineering / Gemology / Geology / Mineralogy / Business Administration or Management / Marketing Management from a recognized University with fifteen (15) years experience in Managerial Level after obtaining the 1st Degree.

Internal Candidates

AND

b) Bachelor's Degree in Mineralogy / Environment Science & Natural Resources Management / Science (Gemology / Mineralogy / Chemistry / Geology / Physics should be as a subject) from a university recognized by the U.G.C.

With

two years certificate course in Gemology from recognized Institution or / Diploma in Gemology (Diploma in Gemology is considered equal to two years certificate course + 2 years experience)

Or

c) Having obtained fellowship of recognized professional Gemological Institute, and a minimum of 05 years post qualifying experience in reputed Gem testing laboratory

Or

d) Having obtained Diploma in Gemology and 10 years post qualifying experience in a reputed Gem testing Laboratory.
