Key duties and responsibilities of the selected candidate would include the following;

- Develop / maintain the vulnerability management programme of the Bank including devising policies, planning and conducting the system security compliance reviews / security assessments as mandated by regulations, compliance standards and Bank policies. Critically analyze assessment results and act as an information security consultant for correcting identified gaps.
- Operate a hands-on role involving penetration testing, Red teaming activities, vulnerability / configuration assessment, etc activities of operating systems, wired and wireless networks, applications including mobile applications, etc.
- Formulate meaningful security metrics / reports to reflect the true posture of the environment allowing the organization to make educated decisions based on risk. Produce actionable, threat-based, reports on security testing results.
- Define / validate system security requirements and baselines necessary to protect systems (OS/ DB), applications, networks, hardware, cloud environments, etc.
- Support ongoing eligibility for annual certification of all applicable standards including ISO 27001, PCI DSS and conformance to regulatory and other mandatory requirements imposed by relevant bodies such as SWIFT, etc.
- Collaborating with the CISO and relevant stakeholders to build on the existing information security programme and manage security projects.
- Evaluating the information security risks and vulnerabilities involved in system changes and launching of new technologies / products / business activities and make appropriate recommendations.
- Independently review / analyze / investigate the security alerts / events via sophisticated cyber security / event management tools to identify areas for improvement and provide recommendations and support for incident response / recovery where necessary.
- Support security operations functions which include but not limited to SIEM, EPP, DLP, and other security implementations and administration as required.
- Research, recommend and provide guidance on mitigating information security vulnerabilities and enhancements for information security related technologies, including developing business cases for security investments.
- Stay abreast on latest information security threats / vulnerabilities, regulations / legislation, advisories and alerts pertaining to the business and make recommendations to the Management as applicable.
