



# Sri Lanka Law College General Entrance Examination

## Admission of Students for Academic Year 2024

Applications are invited for the admission of students to Sri Lanka Law College for Academic Year 2024 through the online system of the Department of Examinations, Sri Lanka from 9. a.m., July 16, 2023 to August 16, 2023.

### Entry Qualifications

The eligible candidates shall possess the following minimum qualifications to sit for the Sri Lanka Law College General Entrance Examination: -

- Shall have passed the Sri Lanka General Certificate of Education (A/L) examination with two Credit passes and one simple pass at one and the same sitting; and
- Shall have obtained Credit passes for English Language and Sinhala or Tamil Language at Sri Lanka General Certificate of Education (O/L) examination or National General Certificate of Education examination.
- Shall have completed 17 years of age at the closing date of receiving applications.

### General Entrance Examination

All applicants must sit for the General Entrance Examination to be held in September 2023. The question papers for the General Entrance Examination of Sri Lanka Law College are as follows:

  - \* General Knowledge and General Intelligence - Time - 03 hours
- (This question paper consists of Two Parts, each 1 1/2 hours)

### Examination Fees and Law College Fees

The examination fee is Rs. 1200/= . Instructions on the mode of payment of the examination fees are published under the technical instructions relevant to the examination in the website of Department of Examinations, Sri Lanka.

Law College fee is Rs. 15000/= . The applicant shall submit his application to the Department of Examination online only after paying the said amount in the name of the applicant to the credit of account, bearing No. 063020073300 (Hulftsdorp branch) of Hatton National Bank in the name of Incorporated Council of Legal Education and the relevant receipt must be forwarded to the e-mail address bearing [entrance@sllc.ac.lk](mailto:entrance@sllc.ac.lk). (The name with initials of the applicant, National Identity Card Number and Telephone number shall necessarily be stated in the receipt which is emailed to the Law College).
