Recruitment to the Post of Telecommunication officer -Grade II of TRCSL - External

Applications are invited from qualified candidates to fill the vacancies of the above post of the Telecommunications Regulatory Commission of Sri Lanka (TRCSL)

(1) Job Description

- Attending to works on Interference Measurement, field strength and Power Measurements.
- Conducting technical investigations and submission of reports
- Conducting technical standards and compliance tests
- Maintenance of measuring and testing equipment
- Assisting the management in executing the duties and functions of the TRCSL

(2) Required Minimum Educational/Professional Qualifications:

A Diploma or similar or a higher academic/vocational qualification, not below the NVQ level 5 or SLQF level 3 or NDT-Katubedda or Equivalent Qualification in Electronics or Telecommunication, conferred either by a university recognized by the University Grants Commission or by an Institute of Technological Training recognized by the Commission.

And

03 Years of post -qualifying experience in the Telecommunication field.

(3) Recruitment Procedure

Through a written competitive examination followed by a structured interview. Appointments will be made purely on the order of merit obtained through the aggregated marks of the competitive examination and the structured interview. Subjects of the written examination are (I) Language Proficiency & Intelligence test (II) Subject Knowledge Relevant to the Post

- (4) Salary:- TRC 5.2 Rs. 54400 (10x1020) -(10x1360)-(10x1700)-(10x2040) 115600. All new appointments to this post will be placed at the initial step of the salary scale relevant to grade II of this Employment Category.
- (5) Age: 18-45 years by the closing date of applications

(6) General Conditions:

- This is a permanent appointment subject to 03 years probation period.
- The TRCSL is a regulatory authority, wherein any person being recruited for employment in the TRCSL shall not promote, advance or advocate directly or indirectly for appointment or employment of his/her spouse or any member of the family in or to a position in an institution that is under the regulatory control of the TRCSL.
- The Telecommunications Regulatory Commission of Sri Lanka (TRCSL) reserves the right to decide on the number of positions to be filled or postponed/cancelled the recruitment
- Applicants who do not possess the required qualifications as at the closing date of applications will not be considered.
- Any form of canvassing will be treated as a disqualification.
