## POST OF DIRECTOR

Applications are invited from suitably qualified and experienced persons for the above post. The prospective applicant should possess postgraduate qualifications and administrative experience.

This is the premier Postgraduate Institute in Sri Lanka for Pali and Buddhist Studies. It provides opportunities for students, both local as well as foreign to pursue postgraduate courses ranging from Postgraduate Diploma to Doctor of Philosophy.

The Director is a full-time officer of the institute and he is the principal executive officer and the principal academic officer. He is also the accounting officer of the institute. He shall be responsible for providing academic leadership, formulating, conducting and introducing management policies and implementing the decisions of the Board of Management.

Preference will be given to reputed senior scholars in Buddhist Studies with experience in postgraduate student training and management.

**Tenure** - 03 years from the date of appointment, or the 65<sup>th</sup> birthday, whichever is earlier.

**Salary** - Those who are presently in the public service and drawing a salary exceeding the initial of the above salary scale will be placed at an equivalent salary point. If the applicant is a teacher defined in the University Act No 16 of 1978, he/she will be paid an academic allowance of 115% – 167% of the salary.

**Age** - Should be below 62 years

The applicant is required to submit, along with his Curriculum Vitae including the date of birth, a statement of vision for the development of the Institute and a brief account of what he proposes to achieve if appointed to the Post of Director. Where the present incumbent is an applicant he should in his report, highlight the contribution made to the development of the Institute concerned during his first term of office and plans for the future.
